PROGRAM OVERVIEW: THIS DAYLONG CONTINUING EDUCATION SYMPOSIUM PROVIDES A WIDE RANGE OF CURRENT TOPICS TO HELP BOTH HEALTHCARE AND PUBLIC HEALTH PROVIDERS OPTIMIZE THE PREVENTION. RECOGNITION, AND MANAGEMENT OF COPD. ATTENDEES OF THE 2013 CAROLINAS COPD SYMPOSIUM WERE ASKED TO PROVIDE THE 3 MOST IMPORTANT INTERVENTIONS LIKELY TO IMPACT COPD OUTCOMES AND THEY WERE: 1) SMOKING CESSATION, 2) EXERCISE, AND 3) PATIENT EDUCATION ABOUT DISEASE AND THERAPIES. WE LISTENED AND THE SYMPOSIUM'S 12 EXPERT FACULTY AND 17 LECTURES/WORKSHOPS WILL COVER THESE AND OTHER CURRENT ISSUES AFFECTING COPD SUGGESTED BY LAST YEARS' ATTENDEES. TOPICS WILL BE RELEVANT FOR THE INDIVIDUAL PATIENT, THE MEDICAL PRACTICE SETTING, LOCAL COMMUNITY, INSTITUTION, AND HEALTHCARE SYSTEM. THERE WILL ALSO BE A GLOBAL PERSPECTIVE OF COPD IN CHINA, THE COUNTRY CONTAINING THE WORLD'S LARGEST COPD POPULATION. TO FACILITATE INTERACTION BETWEEN FACULTY AND ATTENDEES, EACH GENERAL SESSION LECTURE WILL ALLOW FOR 10 MINUTES OF QUESTIONS AND CONCURRENT WORKSHOPS IN THE AFTERNOON WILL ALSO FACILITATE DISCUSSION. THE TARGET AUDIENCE WILL INCLUDE ALL TYPES OF HEALTHCARE AND PUBLIC HEALTH PROVIDERS FROM SOUTH AND NORTH CAROLINA: COPD PATIENTS ARE ALSO WELCOME TO ATTEND. CONTINUING EDUCATION (ACCME, ACPE, AND RESPIRATORY THERAPIST CE CREDITS) WILL BE PROVIDED. COME JOIN US FOR THE DAY TO LEARN MORE ABOUT COPD AND HOW TO IMPACT OUTCOMES OF THE MOST PREVENTABLE MAJOR CAUSE OF DEATH IN THE USA.
